

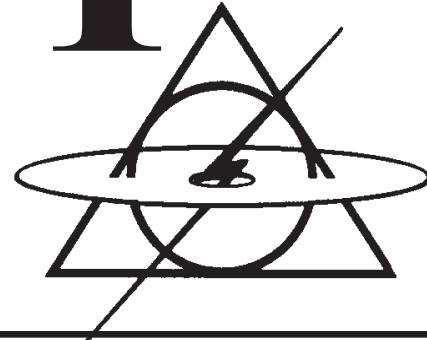

it until GOD hits us upside the head and says LOOK! Then four or five of us sit and claim the message and any “job” is intended for one of the “others”. After all, if gold is on Rick’s picture of Christ, then it must mean a new and magnificent job ahead—surely, for RICK! Rick says, “No, it’s for Doris to type some more,” and then we both offer it as proof E.J. and Charles have to do more.

When and if you get a current folder of our “card” with the inside overlay transparency of the front photograph (of Esu Immanuel Sananda), over the shroud of Turin, put a white sheet of paper between the overlay and the picture of the shroud, and get shocked for yourself. That gold appears as solid material on the negative and does something between your head and heart. I am here, chela, in the Light of Aton.

[EJ: Since it is likely that many readers of this and succeeding issues of CONTACT will be seeing our material for the first time, I will effort to write a rather general introduction. I will also underline some portions of the text to which to draw your attention.

For this introduction let us use His own words: “I am here, chela, in the Light of Aton.” I, in this context, means God/Aton/Allah manifesting as Commander Gyeorgos Ceres Hatonn of the Spacecraft Phoenix (formerly called the Bethlehem at the time it led the “three wise men” to the place of the birth of Esu Immanuel) and herein speaking to His Scribe, calling her affectionately “chela” (which means student). “In the light of Aton” means in the light of God as it was used by the monotheist Pharaohs of Egypt some 5000 years ago. As used here it had a very specific meaning: In the Light of God, and not in the false light of Lucifer, the Prince of Deceit. It was important to Doris to be reassured each time that she was writing for the right entity.

The primary purpose of this short introduction is to assure you readers that what you are reading is the truth and not someone’s opinion. This may not be how you learned it or how you now believe it to be; However, it is how it IS.]

Wow, and where are EXTRA, Tuten, Ence, et. al., when you need them? Ekkers expect a call any minute to find out what is going on in Tehachapi. HISTORY

By the way, there is another book which you would find interesting if you can get a translated version or someone to translate for you. It is called: *LES JUIFS*, by Roger Peyrefitte. Lyndon Johnson of his Jewish ancestors, the Johnsons. It is equally doubtful that at Louveciennes, the Count of Paris was thinking of his Jewish ancestor, Pierloni, who was descendant of the Bourbons through Jeanne d'Albert.**"

I know you would enjoy the information, but if you have no translation possibilities—GO GET: ARTHUR KOESTLER'S *THE THIRTEENTH TRIBE*. There was an effort to BAN the book, wipe out Koestler and cry: *The Protocols* ARE A FORGERY. Well, the book is not even "about" the Protocols, SO YOU CAN GUESS THE CONNECTION.

This book made it through and you can find it in major bookstores along with library copies. If not available go on and order a copy for the ID number for the Library of Congress is 76-10317. We will offer only the list of ten given into print so that you don't have to argue over some other list or wonder why we don't offer more. We don't have either time or space to do YOUR HOMEWORK. Please note that within this list there is reference to "Christian" because this is a bit of "Christian" research. Never mind the limited reference.

[QUOTING:]

1. CHURCH:

Controlled Meaning (CM): A building or organization used by (usually) Christians to meet together weekly to sing, pray and worship once a week.

True Meaning (TM): the English word "church," the Scottish word "Kirk" and the German word "Kirche" all originate from the Greek word KURIOKOS which means "pertaining to the Lord".

[H: Does this portion really sound familiar? I hope so for I just wrote these things less than two days ago.]

The Judeo-Christian use of this word carries with it an enigma that defies all logic. The English *Bible* translators substituted the word KURIOKOS for the Greek word *ECCLESIA*.

2. ECCLESIA

CM: A Christian ecclesia is "A called (convoked) civil body": a local Christian assembly of elders (Christian Civil Government). The word "church" should not even appear in the English *New Testament*. It is a mistranslation. **KURIOKOS IS NOT ECCLESIA!** The words are different; the institutions are different. **Nowhere in the Bible do we find a kuriokos.** There is only "the called-out (elect)" *ecclesia* which unfortunately was MISTRANSLATED into "church," transforming it (in English) from Christian government to superstitious and ritualistic BAAL Worship. **[H: Now, do you want to argue again how King James translated the Bible to suit his own wishes? If you want another good reference get: BAAL WORSHIP by Peter J. Peters.]**

"In the New Testament, ecclesia, signifying 'convocation', is the only single word used (translated) for 'church'. It was the name given to the governmental assembly of the citizens of Athens, duly convoked (called out) by proper officers, and possessing all political power, including even juridical functions." Encyclopedia Britannica, Ninth Edition (1889)

3. SATAN

CM: The Arch-Fallen Angel. An evil being so powerful as to rival God himself. Originally he was "perfect" in every way, but his pride led him to organize a heavenly insurrection among the angels in which one-third of "the heavenly host" revolted against God. God managed to retain his throne, and the rebels were banned from heaven and sent to Earth. Earth, a lesser dominion than heaven, became the kingdom of Satan—"the god of

this world". He is the cause of all evil upon the Earth, leads men astray and causes them to sin against God.

TM: **ANY** adversary or opponent! God was a "satan" (adversary) to King David at one point (compare *2 Sam. 24:1* and *1 Chron. 21:3*). If the English translators had been consistent, *Bible* readers would have known that an angel of the Lord was "a satan" (adversary) to Balaam (*Nu. 22:22*). In *1 Sam. 29:4*, Philistines called a Hebrew a "satan" (adversary). The sons of Zerutah were "satans" (adversaries) to David in *2 Sam. 19:22*. David wrote about other "satans" in *1 Kings 5:4, 11:14 & 25; Ps. 38:20, 109:4, 20, 29*. In these scriptures, "adversary" is the same Hebrew word that is translated "satan" in other passages. **[H: Please note that "satan" is a "term" just as "christ" is a "term" denoting a status of being. If you add or exchange a capital letter as in Satan or Christ YOU HAVE MADE AN EFFORT TO DISQUALIFY THE WORD ITSELF IN MEANING.]**

The super "fallen angel" (Satan) of the churches is an impossible myth. This "evil god" exists only in the bemused minds of victims of religious brainwashing. Human "satans" and "devils" walk the Earth today, just as in the time of King David. Fear and preoccupation with spooks makes people unable to see their real enemies. **[H: However, just as you seem to need some reference to a goodly counsel, Christ, so do you, I suppose, need a bad counsel, Satan or Devil. It leaves a real problem in then changing thoughts about same.]**

4. DEVIL

CM: Synonymous with "Satan." The supernatural arch-demon who fell from heaven, and now, with his legions of demons, reigns over the Earth. God's arch-enemy who spoils God's plans for mankind and destroys people by his power over them. Man does not have the ability to resist "The Devil". Therefore, we are helpless against his power—except when God chooses, periodically, to help us fight him. Mankind is generally under the control of this supernatural "spirit-being" who is immortal, omnipresent, and apparently a rival to God Himself.

BIBLICAL MEANING: In the *Old Testament* this word is found four times—only in the plural (devils). Twice from the Hebrew word "*shade*", and twice from "*saweer*".

1. SHADE: One who rises up against you (with insolence).
2. SAWEER: A he-goat (related to mythological "satyr"—half man, half goat).

Neither of these definitions from the *Old Testament* indicates anything supernatural or angelic. "Shade" simply means someone (anyone) who wants to hurt you. "Saweer" is a reference to a goat-type of idol of the pagans. **[H: You might wish to keep this latter information in mind as you must wonder from where came the symbolic representation of a goat as the symbol of devil, satan, or WITCHCRAFT.]**

The *New Testament* Greek "devil" is "DIABOLOS": One who "thrusts through" (as with a sword)—no indication of supernatural power.

[DIA: through; and BOLOS: TO THRUST.] **[H: Any of you Greeks want to fight over this?]**

A "diabolos" (a devil) is something, or someone, who intends to hurt or destroy *you*. A "devil" can be a person, a group, or an organization that seeks your demise. To find a supernatural "devil" in the Scriptures

he must be read in by prejudice and presupposition on the part of the translators and readers. **[H: You can easily go look up these definitions also—try the ATC Dictionary, May issue, 1988.]**

5. JUDEO-CHRISTIANITY

CM: The religion of Jesus which branched out of Judaism at the time of the early church. Both Christianity and Judaism have the same origins and the same God.

TM: A religion created for the purpose of destroying Christianity by watering down Christian ideals and neutralizing Christians. Also, designed to promote and protect Jews and Judaism.

(NOTE: "Judeo-Christianity" is an **oxymoron**: a word combining TWO OPPOSITE THINGS OR IDEAS which are mutually exclusive, thus defying logic.)

6. HEAVEN

MYTHOLOGICAL DEFINITION: A literal place somewhere in outer space where good people go to live when they are dead. The location where Jesus lives until He can return to Earth and rapture a select few people to take back to heaven. A city is there which has gates literally made of pearls, streets of transparent gold and walls of sapphires, emeralds, topaz, jasper and other precious stones. The devil came from there, but he cannot go back.

CORRECT DEFINITION: Usually plural ("heavens") in the Greek, meaning "high places"—in terms of: 1. Elevation, or 2. Power and authority (jurisdiction). In the *Bible* it is usually "God's government" (the highest authority); government under Jesus whose purity and righteousness is symbolized by pure and precious stones. **[H: Ah, but once again there is the ASSUMPTION (incorrect) that the "christ" to which is referred was named "Jesus". Jesus was inserted to cause mistranslation of the Arabic script into Greek. So, the lies and subterfuge began with the very first writings of the scholars and later pronouncing a bunch of BS prophecies to trap you into coming under the slave-masters of the Anti-CHRIST. If the Anti-Christ wrote the instruction book for human existence and eventual demise, then you begin to see the problem with your ability to overcome the disaster. The people of the Christian attitude simply bind you from learning TRUTH and, thus, continue to maintain and CONTROL you through the ages and into the perceived future. "Jesus Christ" is another one of those oxymorons: "Jesus" is a name affixed to a person while "christ" is a state of being in Grace and perfection. Man and PERFECTION are opposite ideas.]**

7. HOLY SPIRIT

CM: A person or personage of God, either a third person in the Trinity or a third god in a council or godhead. This person is separate from the Father and the Son and has separate and different functions to perform in a believer. In some cases this "third person" can "possess" an individual so that he or she supposedly has no control over actions or words. Sometimes referred to as the "Holy Ghost".

TM: Holy spirit is not a separate person or separate god. The English word "spirit" is translated from the Hebrew *Old Testament* word "RUWACH" (roo'akh) and from the Greek *New Scriptures*, the word is "PNEUMA" (pa-nyew'mah). In both cases the words literally mean "AIR IN MOTION". Spirit is a desire; a feeling or disposition which compels us to move or act. Holy Spirit is God's motivation in our life to do His Will and obey His laws. The word "ghost" is a mistranslation in

the *King James Version Bible*. “Ghost” comes from the German word “geist”, and means a disembodied spirit of a dead person (another myth). It has no appropriate application or association to Scripture.

8. GENTILE

CM: Anyone who is not a Jew, and thus a potential “anti-Semite”.

TM: From the Latin word “entilis”, meaning “of the same gens, clan or race”. In the *Bible*, the word “gentile” is a mistranslation of the *Old Testament* Hebrew word “goy”, and the Greek *New Testament* word “ethnos”—both meaning “NATION OR PEOPLE” (ANY nation or people) and should have been translated as such. It does NOT mean “non-Jewish”!

9. DOCTRINE

CM: Non-essential beliefs, personal eccentricities and inflexible tenets which create differences between churches and destroy fellowship and unity.

TM: Doctrine is a teaching; a principle; a studied conclusion or position. Sometimes called “dogma” (German for “doctrine”). *II Timothy 3:16* says that Scripture is doctrine. *Isaiah 29.24* says that the people who are in error will be able to understand the truth when they learn doctrine.

There is NO “non-essential truth”! None are expendable! None can be discarded or ignored! Truth stated as a principle is doctrine.

Without doctrine it is impossible to teach or arrive at an opinion. Discernment, judgment and corrections would be impossible.

Judeo-Christians sometimes display an “anti-doctrine” attitude; a symptom of ignorance and confusion. Some claim to have a position against doctrine, or one of neutrality concerning it. This is nonsense! Such a position, itself, is a doctrine. An anti-doctrine position exposes an ulterior antipathy for learning and wisdom.

When a person learns true doctrine and then considers it non-essential and chooses to set it aside he contracts chronic spiritual blindness. **[H: Doctrine, therefore, is simply a man-projected set of required opinions on any given subject—not necessarily even remotely relative to TRUTH or REALITY.]**

10. JEW

CM: An Israelite. The seed of Abraham. The Chosen People of the *Bible*. Jews are perpetually persecuted by all other people on Earth. Someone who practices the religion of the *Old Testament*, which is called Judaism. God judges the nations primarily by measuring each nation’s relationship with the Jews. God blesses the nations which support the Jews, but He curses the nations which do not support the Jews. The Christian faith owes its existence to the Jewish culture from whence it was spawned.

[H: Oops, what could this mean? Well, let us consider the loud-mouth presentation of a Col. Bo Gritz as a for instance. He spews about his Jesus connections, his recognition of Isaac under the seed of and through Abraham, and goes on while he tells you HIS DOCTRINE in no uncertain terms and ends up doing what? He has told you that he serves the evil empire, hook, line, and sinker. He is representing the living ANTI-CHRIST and seems to not even have an inkling of his foolishness—OR IS IT INTENT? He and his, et al., are living examples of mis-dis-information in a manner to “getcha” big time.]

INTENT: To bribe and prejudice *Bible*-ignorant Judeo-Christians into passively granting the Jews a carte-blanche to do anything they please WITH IMPUNITY.

TM: The word “Jew” did not appear in actual use until over 1000 years AFTER the so-recognized “resurrection” of the man, Jesus. Where all err is in that first writing in understanding that if an error is printed, then all translations of that error or intent is likewise in error. Dear EJ,

I hope the following information is useful.

I'm writing to give you an update on the "Sipapu Gathering". We had a vacation planned to stop in Tehachapi so my wife and I decided to spend some time there anyway, even with the gathering cancelled. We found it to be a likable sleepy town, cooler than Phoenix, very friendly and relaxed.

We arrived on Aug 15th and left on the afternoon of the 16th. We stayed at the BW Mountain Inn. We found no evidence of a gathering, nor any evidence of an Indian Festival. We asked at the BW hotel desk, several restaurants, picked up a newspaper. There was no publicity for an Indian Festival. There was plenty of information on the Mountain Festival beginning the end of the week, Aug 21st – but again nothing of an Indian Festival.

The one thing that seems to be clear is that the Indian Festival is very important to this project. It is mentioned in the original book, and many of the writings Jonur has received.

As you know in the Contact Hatonn/Jonur wrote August 2, page 2 (Contact Aug 18th), second last paragraph: [quoting]

The Sipapu Odyssey, And they Called His Name Immanuel, I am Sananda, the Tesla movie, and the series of JOURNALS that will comprise the truth in visual format IS the "Hope" of your nation and the world manifested! Do you not see? It has begun! Joseph Clyburn, Jr., the director for these first, beginning projects, will be in Tehachapi California, on August 15th to meet with participants on the Sipapu project. The director and his sister Franziska (Christina) will be in attendance to begin

I do not know who Joseph Clyburn, Jr. is nor do I know if he was in Tehachapi on the 15th of August, had a meeting of the participants on the Sipapu project or anything else about him. I do know that there was no Indian Festival.

When I returned to Phoenix I checked the calendar of events the Tehachapi Chamber of Commerce list. I checked the minutes of the City Council on the web; nothing was mentioned of an Indian Festival. No Indian Festival mentioned at all. The Mountain Festival was mentioned. I called the Loop Newspaper – they knew nothing of an Indian Festival. Either the CofC or the Loop referred me to the Parks Dept. They knew nothing but did refer me to the office of Tomo Kahne. This is the office of an Indian Group, located in Tehachapi. I called. The lady that answered said there was no Indian Festival and that there hadn't been one for as long as she had been there, 4 years. That means that the most recent Indian Festival would have to have been before that, i.e. 2005 or earlier.

What is most perplexing is that Hatonn/Jonur mentioned the Indian Festival in probably half (or more) of the writings about the Sipapu Gathering since 3-24-10. But nothing was even planned. It wasn't cancelled, it just never was. There hadn't even been a festival since 2006.

I think I have included all the pertinent information I can think of.

Really, the only question I have is, shouldn't Hatonn have known that there was no Indian Festival scheduled or planned. To myself I say yes. But on the other hand I have never been with a receiver and don't know what the process is.

I realize this probably [will] not make it in time for the next issue of Contact.

The elections of 2008 (and the early elections of 2010) produced two significant phenomena: the "Ron Paul Revolution," and the "Tea Party Movement". Why do you not see former Minnesota governor Jesse Ventura on Fox News? Why do you not see former Director of the US Office of Economic Opportunity and Presidential candidate Howard Phillips on Fox News? Why do you not see Presidential candidate Chuck Baldwin on Fox News? The list is endless.

Fox News is not "fair and balanced". It is as controlled

and manipulated as any other media news network. The only thing it balances is the other networks' infatuation with the Democrat Party, by promoting Republican candidates and ideas. What it does not do is educate and inform the American people with the truth as to what both major parties are doing to destroy our country. But remember, Fox News is owned by Keith Rupert Murdoch, the same man who helped finance Hillary Clinton's campaign for the US Senate, and who is as much of a globalist as anyone in Washington, D.C., or New York City.

The State and Local Bases of Zionist Power in America

Introduction

Any serious effort to understand the extraordinary influence of the Zionist power configuration over US foreign policy must examine the presence of key operatives in strategic positions in the government and the activities of local Zionist organizations affiliated with mainstream Jewish organizations and religious orders.

There are at least 52 major American Jewish organizations actively engaged in promoting Israel's foreign policy, economic and technological agenda in the US (see the appendix). The grassroots membership ranges from several hundred thousand militants in the Jewish Federations of North America (JFNA) to one hundred thousand wealthy contributors, activists and

power brokers in the American Israel Public Affairs Committee (AIPAC). In addition scores of propaganda mills, dubbed think tanks, have been established by million dollar grants from billionaire Zionists including the Brookings Institute (Haim Saban) and the Hudson Institute among others. Scores of Zionist funded political action committees (PAC) have intervened in all national and regional elections, controlling nominations and influencing election outcomes. Publishing houses, including university presses have been literally taken over by Zionist zealots, the most egregious example being Yale University, which publishes the most unbalanced tracts parroting Zionist parodies of Jewish history (Financial Times book review section August 28/29 2010). New heavily funded Zionist projects designed to capture young Jews and turn them into instruments of Israeli foreign policy includes "Taglit-Birthright" which has spent over \$250 million dollars over the past decade sending over a quarter-million Jews (between 18-26) to Israel for 10 days of intense brainwashing (*Boston Globe* August 26, 2010). Jewish billionaires and the Israeli state foot the bill. The students are subject to a heavy dose of Israeli style militarism as they are accompanied by Israeli

soldiers as part of their indoctrination; at no point do they visit the West Bank, Gaza or East Jerusalem (*Boston Globe* August 26, 2010). They are urged to become dual citizens and even encouraged to serve in the Israeli armed forces. In summary the 52 member organizations of the Presidents of the Major American Jewish Organizations which we discuss are only the tip of the iceberg of the Zionist Power Configuration: taken together with the PACs, the propaganda mills, the commercial and University presses and mass media we have a matrix of power for understanding the tremendous influence they have on US foreign and domestic policy as it affects Israel and US Zionism.

While all their activity is dedicated first and foremost in ensuring that US Middle East policy serves Israel's colonial expansion in Palestine and war aims in the Middle East, what B'nai B'rth euphemistically calls a "focus on Israel and its place in the world", many groups 'specialize' in different spheres of activity. For example, the "Friends of the Israel Defense Force" is primarily concerned in their own words "to look after the IDF", in other words provide financial resources and promote US volunteers for a foreign army (an illegal activity except when it involves Israel). Hillel is the student arm of the Zionist power configuration claiming a presence in 500 colleges and universities, all affiliates defending each and every human rights abuse of the Israeli state and organizing all expenses paid junkets for Jewish student recruits to travel to Israel where they are heavily propagandized and encouraged to 'migrate' or become 'dual citizens'.

Method: Studying Zionist Power:

There are several approaches for measuring the power of the combined Zionist organizations and influential occupants of strategic positions in government and the economy. These include (a) reputational approach (b) self claims (c) decision-making analysis (d) structural inferences. Most of these approaches provide some clues about Zionist potential power. For example, newspaper pundits and journalists frequently rely on Washington insiders, congressional staff and notables to conclude that AIPAC has the reputation for being one of the most powerful lobbies in Washington. This approach points to the need to empirically examine the operations of AIPAC in influencing Congressional votes, nomination of candidates, defeating incumbents who do not unconditionally support the Israeli line. In other words analyzing the Congressional and Executive decision-making process is one key to measuring Zionist power. But it is not the only one. Zionist power is a product of a historical context, where media ownership and wealth concentration and other institutional levers of power come into play and shape the current decision-making framework. Cumulative power over time and across institutions creates a heavy bias in the political outcomes favorable to Israel's organized agents in America. Once again the mere presence of Jews or Zionists in positions of economic, cultural and political power does not tell us how they will use their resources and whether they will have the desired effect. Structural analysis, the location of Zionists in the class structure, is necessary but not sufficient for understanding Zionist power. One has to proceed and analyze the content of decisions made and not made regarding the agenda of Israel's backers operating in the USA. The 52 major Zionists organizations are

very open about their claims to power, their pursuit of Israel's agenda and their subservience to each and every Israeli regime. **[EJ: This is beginning to sound like an academic grant application.]**

Those who deny Zionist power over US Mid East foreign policy are left-Zionists namely Noam Chomsky and his acolytes. They never analyze the legislative process, executive decision-making, the structures and activity of the million member Zionist grassroots and the appointments and background of key policy makers deciding strategic policies in the Middle East. Instead they resort to superficial generalizations and political demagoguery, imputing policy to "Big Oil" and the "military-industrial complex" or "US imperialism". Categories devoid of empirical content and historical context about real existing policy making regarding the Middle East.

The Making of Zionist Power in the US Government

To understand US submission to Israeli war policies in the Middle East one has to look beyond the role of lobbies pressuring Congress and the role of political action committees and wealthy Zionist campaign contributions. A much neglected but absolutely essential building block of Zionist power over US foreign economic, diplomatic and military policy is the Zionist presence in key policy positions, including the Departments of Treasury and State, the Pentagon, the National Security Council and the White House. **[EJ: Is this a revelation? Not to CONTACT readers, of course.]**

Operating within the top policymaking positions, Zionist officials have consistently pursued policies in line with Israel's militarist policies, aimed at undermining and eliminating any country critical of the Jewish States' colonial occupation of Palestine, its regional nuclear monopoly, its expansion of Jews only settlements and above all its strident efforts to remain the dominant power in the Arab East. The Zionist policymakers in Government are in constant consultation with the Israeli state, ensuring coordination with the Israeli military (IDF) command, its Foreign Office and secret police (MOSSAD) and compliance with the Jewish State's political line. Over the past 24 months not a single Zionist policymaker has voiced any criticism of Israel's most heinous crimes, ranging from the savaging of Gaza to the massacre of the humanitarian flotilla and the expansion of new settlements in Jerusalem and the West Bank. A record of loyalty to a foreign power which even exceeds the subservience of the Stalinist and Nazi fellow travelers in Washington during the 1930's and 1940's.

Zionist policymakers in strategic positions depend on the political backing and work closely with their counterparts in the "lobbies" (AIPAC) in Congress and in the national and local Jewish Zionist organizations. Many of the leading Zionist policymakers rose to power through a deliberate strategy of infiltrating the government to shape policy promoting Israel's interest over and above the interests of the US populace. While a degree of cohesion resulting from a common allegiance to Tel Aviv can account for suspected nepotism and selection, it is also the case that the powerful Jewish lobbies can play a role in creating key positions in Government and ensuring that one of their own will occupy that position and pursue Israel's

agenda.

Stuart Levey: Israel's Foremost Operative in the US Government

In 2004, AIPAC successfully pressured the Bush Administration to create the office of Undersecretary for Terrorism and Financial Intelligence (UTFI) and to name its protégé Princeton graduate Stuart Levey to that position. Before, but especially after his appointment, Levey was in close collaboration with the Israeli state and was known as an over the top Zionist zealot with unbounded energy and blind worship of the Israeli state.

Within the confines of his Zionist ideological blinders, Levey applied his intelligence to the singular task of turning his office into the major foreign policy venue for setting US policy toward Iran. Levey more than any other appointed official in government or elected legislator, formulates and implements policies which profoundly influence US, European Union and UN economic relations with Iran. Levey elaborated the sanctions policies, which Washington imposed on the EU and the Security Council. Levey, organizes the entire staff under his control at Treasury to investigate trade and investment policies of all the world's major manufacturing, banking, shipping, petroleum and trading corporations. He then criss-crosses the US and successfully pressures pension funds, investment houses, oil companies and economic institutions to disinvest from any companies dealing with Iran's civilian economy. He has gone global, threatening sanctions and blackballing dissident companies in Europe, Asia, the Middle East and North America which refuse to surrender economic opportunities. They all understood Levey operated at the behest of Israel, services Levey has proudly performed.

Levey coordinates his campaign with Zionist leaders in Congress. He secures sanctions legislation in line with his campaigns. His policies clearly violate international law and national sovereignty, pressing the limits of extra territorial enforcement of his administrative fiat against a civilian economy. His violation of economic sovereignty parallels Obama's announcement that US Special Forces would operate in violation of political sovereignty on four continents. For all intents and purposes, Levey makes US policy toward Iran. At each point he designs the escalation of sanctions, and then passes it on to the White House, which shoves it down the throats of the Security Council. Once new sanctions approved by Levey and staff are in place they are there to enforce them: identifying violators and implementing penalties. Treasury has become an outpost of Tel Aviv. Not a single leftist, liberal or social democratic publication highlights the role of Levey or even the terrible economic pain this Old Testament fanatic is inflicting on 75 million Iranian civilian workers and consumers. Indeed like Israel's Judeo-fascist rabbis who preach a "final solution" for Israel's enemies, Levey announces new and harsher "punishment" against the Iranian people (Stuart Levey, "Iran's New Deceptions at Sea Must be Punished" FT 8/16/2010, p. 9). Perhaps at the appropriate moment the Jewish State will name a major avenue through the West Bank for his extraordinary services to this most unholy racist state.

The Strategic Role of Local Power

The Israel Lobby Archive recently released declassified documents of the American Zionist Council (AZC) subpoenaed during a US Senate investigation between 1962-63. The documents reveal how the Israeli state through its American Jewish conduits – the mainstream Zionist organizations – penetrated the US mass media and propagated its political line, unbeknownst to the American public. Stories written by a host of Jewish Zionist journalists and academics were solicited and planted in national media such as *The Readers Digest*, *The Atlantic Monthly*, *Washington Post* among others, including regional and local newspapers and radio stations (Israel Lobby Archive, August 18, 2010). While the national Zionist organizations procured the journalists and academic writers and editors, it was the local affiliates who carried the message and implemented the line. The level of infiltration the Senate subpoenaed Zionist documents in the 1960's reveal has multiplied a hundred fold over the past 50 years in terms of financing, paid functionaries and committed militants and above all in structural power and coercive capability.

While the national leaders in close consultation with Israeli officials receive instructions on which issues are of high priority, the implementation follows a vertical route to regional and local leaders, politicians, and notables who in turn target the local media and religious, academic and other opinion leaders. When national leaders ensure publication of pro Israeli propaganda, the locals reproduce and circulate it to local media and non-Zionist influentials on their "periphery". Letter campaigns orchestrated at the top are implemented by thousands of militant Zionist doctors, lawyers and businesspeople. They praise pro-Israel scribes and attack critics; they pressure newspapers, publishing houses and magazines not to publish dissidents. The national and local leaders promote hostile reviews of books not promoting the Israeli line, influence library decisions to pack their shelves with pro Israeli books and censor and exclude more balanced or critical histories. Local militants in co-ordination with Israeli consuls saturate the public with thousands of public meetings and speakers targeting Christian churches, academic audiences and civic groups; at the same time local Zionist militants and, especially millionaire influentials, pressure local venues (university administrators, church authorities and civic associations) to disinvite any critic of Israel and their supporters from speaking. In the last resort, local Zionists demand that a pro-Israel propagandist be given equal time, something unheard of when an Israel apologist is scheduled to speak.

Local Zionist organizations make yeoman efforts to recruit mayors, governors, local celebrities, publishers, church people and promising young ethnic and minority leaders by offering them all expenses paid propaganda junkets to Israel and then to write or give interviews parroting what they were fed by Israeli officials. Local leaders mobilize thousands of militant activist Zionists to attack anti-Zionist Jews in public and private. They demand they be excluded from any media roundtables on the Middle East.

Local Zionist functionaries form rapid response committees to visit and threaten any local publisher and editorial staff publishing editorials or articles questioning the Israeli party line. Local leaders police

(“monitor”) all local meetings, speaker invitations, as well as the speeches of public commentators, religious leaders and academics to detect any “anti-Zionist overtones” (which they label “covert anti-Semitism”). Most of the major Jewish religious orders are lined up as the clerical backbone of local Israeli fundraising, including the financing of new “Jews only” settlements in the Palestinian West Bank.

Local functionaries are in the forefront of campaigns to keep independent Middle East specialists and public policy academics, appointments, tenure or promotion, independently of the quality of their scholarship. On the other hand, academic hacks who toe the pro-Israel line, by publishing books with blanket attacks on Israeli critics among Christians and Muslims and countries like Turkey, Iran or whoever is a target of Israeli policy, are promoted, lauded and put on the best seller list. Any book or writer critical of Zionist Power or Israel is put on a local and national ‘index’ and subject to an inquisition by slander from a stable of Jewish Torquemadas.

Conclusion

The power of Israel in the US does not reside only in the influence and leadership of powerful Washington based “pro-Israel lobbies”, like AIPAC. Without the hundreds of thousands of militant locally based dentists, podiatrists, stockbrokers, real estate brokers, professors and others, the “lobby” would be unable to sustain and implement its policy among hundreds of millions of Americans outside the major metropolises. As we have seen from the Senate declassified documents, over a half-century ago, local Zionist organizations began a systematic campaign of penetration, control and intimidation that has reached its pinnacle in the first decade of the 21st century. It is no accident or mere coincidence that University officials in Northern Minnesota or upstate New York are targeted to exclude speakers or fire faculty members critical of Israel. Local Zionists have computerized databanks operating with an index of prohibited speakers, as the Zionists themselves admit and flaunt in contrast to “liberal” Zionists who are prone to label as “anti-Semitic” or “conspiracy theorists” writers who cite official Zionist documents demonstrating their systematic perversion of our democratic freedoms.

Over the decades, the distinction between Zionist power exercised by a “lobby” outside the government and operatives “inside” the government has virtually vanished. As we have seen, in our case study, AIPAC secured the undersecretary position in Treasury, dictated the appointment of a key Zionist operative (Stuart Levey) and accompanies his global crusade to sanction Iran into starvation and destitution. The planting of operatives within key Middle East positions in government is not the simple result of individual career choices. The ascent of so many pro-Israel Zionist to government posts is part of their mission to serve Israel’s interest at least for a few years of their careers. Their presence in government precludes any Senate or Congressional investigations of Zionists organizations acting as agents of a foreign power as took place in the 1960’s.

As the major Zionist organizations and influentials have accumulated power and abused the exercise of power on behalf of an increasingly bloody racist state, which

flaunts its dominance over US institutions, public opposition is growing. The Boycott, Divestment and Sanctions campaign is gaining strength even in the US (see Harvard divestment in Israeli companies). US public support for Israel, by all measures, has dropped below 50%, while polls in Western Europe show a marked increase in hostility to Israel’s ultra-rightist regime. Anti-Zionist Jews are growing in influence especially among young Jews who are appalled by the Israeli slaughter in Gaza and assault on the humanitarian flotilla. Equally important the presence of anti-Zionist Jews on panels and forums has given courage to many otherwise intimidated non-Jews who heretofore were fearful of being labeled “anti-Semitic”.

The Zionist power configuration rests on a declining population base: most young Jews marry outside the confines of the ethno-religious Jewish-Israeli nexus and many of them are not likely to form the bases for rabid campaigns on behalf of a racist state. The Zionist leadership’s high intensity and heavily endowed effort to fence in young people of Jewish ancestry via private schools, subsidized “summer programs” in Israel, etc., are as much out of fear and recognition of the drift away from clerical chauvinism as it is an attempt to recruit a new generation of Israel First militants.

The danger is that the US Zionist support for the ultra-rightist and racist regime in Israel is leading them to join forces with the far right in the US. Today Jewish and Christian Manhattan rednecks are fermenting mass Islamic hatred (the so called “Mosque controversy”) as a distraction from the economic crises and rising unemployment. Zionist promotion of mass Islamofobia, so near to Wall Street, where many of their fat cats who profit from plundering the assets of America operate, is a dangerous game. If the same enraged masses turn their eyes upward toward the wealthy and powerful instead of downward to blacks and Muslims, some unpleasant and unanticipated surprises might rebound against, not only Israel’s operatives, but all those wrongly identified as related to a misconstrued Jewish Motherland.

Bedouin Land fight: Claim for Native Title threatens Jewish State

Nuri al Uqbi’s small cinderblock home in a ramshackle neighborhood of Hura, a Bedouin town in Israel’s Negev desert, hardly looks like the epicenter of a legal struggle that some observers say threatens Israel’s Jewish character.

Inside, the 68-year-old Bedouin activist has stacks of bulging folders of tattered and browning documents, many older than the state of Israel itself, that he hopes will overturn decades of harsh government policy towards the Negev’s 180,000 Bedouin.

For the past few months, Mr. al Uqbi has been in court pursuing a case that has pitted his own expert witnesses against those of the state.

Mr. al Uqbi claims the right to return to a patch of 82 hectares in the Negev, close to the regional capital, Beersheva, that he says has belonged to his family

for generations. But as both the government and the judge in the case, Sarah Dovrat, seem to appreciate, much more is at stake. **[EJ: Yes indeed; the truth will out. Disaster cubed for the Israelis and a mammoth headache for Judge Sarah Dovrat. How can she rule so that it goes to Appeal, relieving her of the responsibility and saving her career? When it goes to Appeal it is likely to have no less than one billion Muslims behind Mr. al Uqbi. Bad times for Israel?]**

Should Mr. al Uqbi win his case, tens of thousands of Bedouin, who long ago had their properties confiscated, could be entitled to repossess their agricultural lands or seek enormous sums in compensation.

Theoretically, it might also open the door to claims by millions of Palestinian refugees scattered across the Middle East.

The Negev, constituting nearly two-thirds of Israel’s territory, has been almost entirely nationalized by the state, with the land held in trust for world Jewry. But the Bedouin have outstanding legal claims on nearly 80,000 hectares of ancestral property.

Tom Segev, an Israeli historian, observed that the historical documents presented by Mr. al Uqbi “raise a fundamental question: Who does this country belong to?”

The lawyers and witnesses in the case, Mr. Segev added, were not just “arguing over a plot of land. They are arguing over the justness of Zionism.”

Such high stakes may explain why over the past few weeks, as Ms Dovrat has been considering her verdict, the authorities have sped up plans to plant over Mr. al Uqbi’s land a “peace forest”, paid for by an international Zionist charity called the Jewish National Fund (JNF).

Until now the main obstacle in their way has been a small village, Al Araqib, re-established a decade ago by several Bedouin families who, rather than pursue Mr. al Uqbi’s legal route, have simply reoccupied the land.

Last week, about 300 Bedouin were again evicted when the police destroyed the village’s 40 homes for the fourth time in less than a month.

Mr. al Uqbi, a father of eight, said that five years ago—after years of challenging the land confiscation with protests and appeals to the authorities—he launched the lengthy legal process that has finally reached the Beersheva court.

“I realized that the authorities were simply waiting for me to die. When all the old people are gone, who will be left to come and testify?”

Mr. al Uqbi said his father, Sheikh Suleiman al Uqbi, and the other villagers were “tricked” by the authorities in 1951. They were told that they would have to relocate “temporarily” while military exercises were carried out in the area.

Mr. al-Uqbi, who was nine at the time, remembers the tribe being forcibly moved to a new site, next to Hura, where they have lived ever since, although their neighborhood has never been recognized by the state.

All these years later, Mr. al Uqbi’s home, like his neighbors’, is still illegal, and they are all denied water, electricity and other services.

Jon Stewart is the only pundit to take-on the question of the Ground Zero mosque’s funding with anything like detail.

The only option they had been offered to make their lives legal again, Mr. al Uqbi said, was to move to one of seven government “townships” set up in the 1970s. All are sunk at the very bottom of Israel’s social and economic tables.

The families have refused, protesting that they would also have to renounce both their claim to their ancestral lands and a pastoral and agricultural way of life known by the Bedouin for centuries. The Uqbi tribe’s fate is far from unique. Tens of thousands of other Bedouin were also moved by the army and have been faced with a similar, stark choice.

Today, 90,000 Bedouin, or half the Negev’s Bedouin population, live in unrecognized communities, according to a human rights group.

Mr. al Uqbi’s court case has set two noted Israeli geography professors in sharp opposition.

The state’s position is represented by Ruth Kark, of Hebrew University in Jerusalem, who claims that the Negev Bedouin were nomads with no ties to the land. Instead, she argues, most of the Negev was considered “mawat”, or dead, and its ownership passed to Israel in 1948 as the new sovereign ruler.

On these grounds, the state has long classified the Bedouin as “trespassers” and “invaders”.

But Mr. al Uqbi’s expert, Oren Yiftachel, of Ben Gurion University in Beersheva, has countered that there was a well-established system of Bedouin land ownership and crop cultivation in the Negev long before Israel’s creation.

He says Bedouin deeds—though never formally recorded—were recognized by the Ottomans, the British and even early Zionist organizations such as the JNF, which bought land from the Bedouin.

A 1921 document from the public records office in London unearthed by Mr. Yiftachel shows that Winston Churchill, the colonies minister, signed an agreement with Bedouin in the Beersheva area that exempted them from registering their lands and set up a special tribal court to settle land disputes.

Mr. al Uqbi has kept a large store of documents passed on to him, showing that his father cultivated crops on the land and paid regular tithes on the profits to the Ottoman and British authorities.

He also has a copy of the treaty signed in 1948 between 16 Bedouin tribes, including the Uqbi, and the new Israeli army, pledging loyalty in return for a guarantee that they could continue living on their lands.

Mr. Yiftachel said the legal battles of the Bedouin should be compared to those waged by other indigenous peoples in countries such as Australia, Canada, South Africa, India and Brazil. “Like them, they are fighting for recognition of ‘native title,’” he said.

WHAT A GOVERNMENT CAN DO WITH ITS OWN BANK: THE REMARKABLE MODEL OF THE COMMONWEALTH BANK OF AUSTRALIA

Virg Bernero, the mayor of Lansing, Michigan, just won the Democratic nomination for governor of his state, making a state-owned Bank of Michigan a real possibility. Bernero is one of at least a dozen candidates promoting that solution to the states' economic woes. It is an innovative idea, with little precedent in the United States. North Dakota, currently the only state owning its own bank, also happens to be the only state sporting a budget surplus, and it has the lowest unemployment rate in the country; but skeptics can write these achievements off to coincidence. More data is needed, and fortunately other precedents are available from other countries.

One of the most dramatic is the Commonwealth Bank of Australia, which operated successfully as a government-owned bank for most of the 20th century, until it was privatized in the 1990s. The Commonwealth Bank's creative founders demonstrated that a government-backed bank can make loans without capital. Denison Miller, the Bank's first Governor, was fond of saying that the Bank did not need capital because "it is backed by the entire wealth and credit of the whole of Australia."

The Commonwealth Bank's accomplishments were particularly remarkable considering that for its first eight years, from 1912 to 1920, it did not have the power to issue the national currency—unlike the U.S. Federal Reserve, which acquired that power in 1913. The Commonwealth Bank was thus in the same position as a state of the United States or a member country of the European Union (think Greece), which also lack the power to issue their own currencies. Operating without that power and without startup capital, the Commonwealth Bank funded both massive infrastructure projects and the country's participation in World War I. According to David Kidd, writing in a 2001 article titled "How Money Is Created in Australia":

“Australia’s own government-established Commonwealth Bank achieved some impressive successes while it was ‘the peoples’ bank’, before being crippled by later government decisions and eventually sold. At a time when private banks were demanding 6% interest for loans, the Commonwealth Bank financed Australia’s First World War effort from 1914 to 1919 with a loan of \$700,000,000 at an interest rate of a fraction of 1%, thus saving Australians some \$12 million in bank charges. In 1916 it made funds available in London to purchase 15 cargo steamers to support Australia’s growing export trade. Until 1924 the benefits conferred upon the people of Australia by their Bank flowed steadily on. It financed jam and fruit pools to the extent of \$3 million, it found \$8 million for Australian homes, while to local government bodies, for construction of roads, tramways, harbors, gasworks, electric power plants, etc., it lent \$18.72 million. It paid \$6.194 million to the Commonwealth Government between December, 1920 and June, 1923—the profits of its Note Issue Department—while by 1924 it had made on its other business a profit of \$9 million, available for redemption of debt. The bank’s independently-minded Governor, Sir Denison Miller, used the bank’s credit power after the First World War to save Australians from the depression conditions being imposed in other countries. . . . By 1931 amalgamations with other banks made the Commonwealth Bank the largest savings institution in Australia, capturing 60% of the nation’s savings.”

Harnessing the Secret Power of Banking for the Public Good

The Commonwealth Bank was able to achieve so much with so little because its first Governor, Denison Miller, and its first and most ardent proponent, King O’Malley, had both been bankers themselves and knew the secret of banking: that banks create the “money” they lend simply by writing accounting entries into the deposit accounts of borrowers.

This banking secret was confirmed by a number of early banking insiders. In a 1998 paper titled “Manufacturing Money”, Australian economist Mike Mansfield quoted the Rt. Hon. Reginald McKenna, former Chancellor of the Exchequer, who told shareholders of the Midland Bank on January 25, 1924, “I am afraid the ordinary citizen will not like to be told that *the banks can, and do, create and destroy money. The amount of money in existence varies only with the action of the banks in increasing or decreasing deposits and bank purchases.* We know how this is effected. Every loan, overdraft or bank purchase creates a deposit, and every repayment of a loan, overdraft or bank sale destroys a deposit.”

Dr. Coombs, former Governor of the Reserve Bank of Australia, said in an address at Queensland University on September 15, 1954, “[W]hen money is lent by a bank it passes into the hands of the person who borrows it without anybody having less. Whenever a bank lends money there is therefore, an increase in the total amount of money available.”

Ralph Hawtrey, Assistant Under Secretary to the British Treasury in the 1930s, wrote in *Trade Depression and the Way Out*, “When a bank lends, it creates money out of nothing.” In his book *The Art of Central Banking*, Hawtrey expanded on this statement, writing, “When a bank lends, it creates credit. Against the advance which it enters amongst its assets, there is a deposit entered in its liabilities. But other lenders have not the mystical power of creating the

means of payment out of nothing. What they lend must be money that they have acquired through their economic activities.”

Banks can do what no one else can: “create the means of payment out of nothing.” The Commonwealth Bank’s far-sighted founders harnessed this guarded banking secret to serve the public interest.

The Bank Collapse of 1893 Spawns a New Public Banking Model

The Commonwealth Bank was founded under conditions like those prevailing today: the country had just suffered a massive banking collapse. In the 1890s, however, there was no FDIC insurance, no social security, no unemployment insurance to soften the blow. People who thought they were well off suddenly found they had nothing. They could not withdraw their funds, write checks on their accounts, or sell their products or their homes, since there was no money with which to buy them. Desperate people were leaping from bridges or throwing themselves in front of trains. Something had to be done.

The response of the Labor government was to pass a bill in 1911 which included a provision for a publicly-owned bank that would be backed by the assets of the government. In a rare move for the time, the bank was to have both savings and general bank business. It was also the first bank in Australia to receive a federal government guarantee.

Jack Lang was Australia’s Treasurer in the Labor government of 1920-21 and Premier of New South Wales during the Great Depression. A controversial figure, he was relieved of his duties after he repudiated loans owed to the London bankers. In *The Great Bust: The Depression of the Thirties* (McNamara’s Books, Katoomba, 1962), Lang described the Commonwealth Bank’s triumphs and tribulations in revealing detail. He wrote:

“The Labor Party decided that a National Bank, backed with the assets of the Government, would not fail in times of financial stress. It also realized that such a bank would be a guarantee that money would be found for home building and other needs. After the collapse of the building societies, there was a great scarcity of money for such purposes.

“. . . Chief advocate of the cause of a Commonwealth Bank was King O’Malley, a colorful Canadian-American . . . Before coming to Australia, he had worked in a small New York bank, owned by an uncle. . . . He had been much impressed by the way that his uncle had created credit. *A bank could create the credit, and at the same time manufacture the debit to balance it. That was the big discovery of O’Malley’s banking career.* A born showman, he itched to try it out on a grand scale. He started his political career in South Australia by advocating a State Commercial Bank. In 1901 he went into the first Federal Parliament as a one-man pressure group to establish a Commonwealth Bank, and joined the Labor Party for that purpose.”

King O’Malley insisted that the Commonwealth Bank had to control the issue of its own notes, but he lost on that point—until 1920, when the Bank did take over the issuance of the national currency, just as the U.S. Federal Reserve was authorized to do in 1913. That was the beginning of the Commonwealth Bank’s central bank powers. But even before it had that power, the Bank was able to fund infrastructure and defense on a massive scale, and it did this without startup capital. These achievements were chiefly due to the insights and boldness of the Bank’s first Governor, Denison Miller.

The other bankers, fearing competition, had thought that by getting one of their own men in as the bank’s governor, they could keep it in line. But they had not reckoned on their independent appointee, who saw the opportunity posed by a government-backed bank and set out to make it the finest institution the country had ever known. As Lang tells the story:

“The first test came when a decision was required regarding the amount of capital needed to start a bank of that kind. Under the Act, the Commonwealth had the right to sell and issue debentures totaling £1 million. Some even thought that amount of capital would be insufficient, having in mind what had happened in 1893. . . .

“When Denison Miller heard of it, his reply was that no capital was needed.”

Miller was wary of going to the politicians for money. He could get by without capital. Like King O’Malley, he knew how banking worked. (This was, of course, before the modern-day capital requirements imposed from abroad by the central banker’s bank, the Bank for International Settlements.) Lang continued:

“Miller was the only employee. He found a small office . . . and asked the Treasury for an advance of £10,000. That was probably the first and last time that the Commonwealth lent the Bank any money. From then on, it was all in the reverse direction.

“. . . By January, 1913 [Miller] had completed arrangements to open a bank in each State of the Commonwealth, and also an agency in London. . . . [O]n January 20th, 1913 he made a speech declaring the new Commonwealth Bank open for business. He said:

““This bank is being started without capital, as none is required at the present time, but it is backed by the entire wealth and credit of the whole of Australia.”

“In those few simple words was the charter of the Bank, and the creed of Denison Miller, which he never tired of reciting. He promised to provide facilities to expand the natural resources of the country, and it would at all times be a people’s bank. ‘There is little doubt that in time it will be classed as one of the great banks of the world,’ he added prophetically.

“. . . Slowly it began to dawn on the private banks that they may have harbored a viper. They had been so intent on the risks of having to contend with bank socialization that they didn’t realize they had much more to fear from competition by an orthodox banker, with the resources of the country behind him.

“. . . One of the first demonstrations of his vigor came when the Melbourne Board of Works went on the market for money to redeem old loans, and also to raise new money. Up to that time, apart from Treasury Bills and advances by their own Savings Banks, Governments had depended on overseas loans from London. . . . In addition to stiff underwriting charges, they found that the best they could expect would be £1 million at 4 per cent., at 97 1/2 net.

“They then decided to approach Denison Miller, who had promised to provide special terms for such bodies. He immediately offered to lend them £3 millions at 95 on which the interest rate would be 4 per cent. They immediately clinched the deal.

Asked where his very juvenile bank had raised all that money, Miller replied, ‘On the credit of the nation. It is unlimited.’”

Another major test came in 1914 with the First World War:

“The first reaction was the risk that people might start rushing to the banks to withdraw their money. The banks realized that they were still vulnerable if that happened. They were still afraid of another Black Friday.

“There was a hurried meeting of the principal bankers. Some reported that there were signs that a run was already starting. Denison Miller then said that the Commonwealth Bank on behalf of the Commonwealth would support any bank in difficulties. . . . That was the end of the panic. But it put Miller on the box seat. Now, for the first time, the Commonwealth Bank was taking the lead. It was giving, not taking, orders. . . .

“Denison Miller . . . was virtually in control of the financing of the war. The Government didn’t know how it was going to be achieved. Miller did.”

And so this interesting story continues. Miller died in 1923, and in 1924 the bankers got back in control, throttling the activities of the Commonwealth Bank and preventing it from saving Australians from the ravages of the 1930s Depression. In 1931, the bank board came into conflict with the Labor government of James Scullin. The Bank’s chairman refused to expand credit in response to the Great Depression unless the government cut pensions, which Scullin refused to do. Conflict surrounding this issue led to the fall of the government, and to demands from Labor for reform of the bank and more direct government control over monetary policy.

The Commonwealth Bank received almost all of the powers of a central bank in emergency legislation passed during World War II, and at the end of the war it used this power to begin a dramatic expansion of the economy. In just five years, it opened hundreds of branches throughout Australia. In 1958 and 1959, the government split the bank, giving the central bank function to the Reserve Bank of Australia, with the Commonwealth Banking Corporation retaining its commercial banking functions. Both banks, however, remained publicly-owned.

Eventually, the Commonwealth Bank had branches in every town and suburb; and in the bush, it had an agency in every post office or country store. As the largest bank in the country, it set the rates and set policy, which the others had to follow for fear of losing customers. The Commonwealth Bank was widely perceived to be an insurance policy against abuse by private banks, serving to ensure that everyone had access to equitable banking. It functioned as a wholly owned state bank until the 1990s, when it was privatized. Its focus then changed to maximization of profits, with steady and massive branch and agency closures, staff layoffs, and reduced access to Automated Teller Machines and to cash from supermarket checkouts. It has now become just another part of the banking cartel, but proponents say it was once the lifeblood of the country.

Today there is renewed interest in reviving a publicly-owned bank in Australia on the Commonwealth Bank model. The United States and other countries would do well to consider that option too. Any proposed legislation should contain careful checks for accountability. The Commonwealth Bank served Australia brilliantly well for its first 11 years under the stewardship of one honest man, Denison Miller. When he passed away in 1923, the bank was delivered into the hands of a board of businessmen more

interested in serving their own interests than the nation’s. Legislation would need to be drafted that prevented that from happening again.

8 Invented Diseases Big Pharma Is Banking on

[EJ: I feel really guilty for seeing so much humor and having so much fun with this while I sit here in front of this idiot (sometimes seems smarter than me) electronic gadget called a computer which 90% of the time computes nothing. My first giggle began with reading the author’s name. Sure, there are lots of good Jewish people with Jewish names but even a mule gets “head-shy” after so many lessons so I can ask for some slack. However, when you put the rest of this in the modern AIPAC-approved context of “We’ve got you now,” maybe you can get some humor, too. I hope so.]

Since direct-to-consumer drug advertising debuted in 1997, Pharma’s credo has been When The Medication Is Ready, The Disease (and Patients) Will Appear. Who knew so many people suffered from restless legs?

But Pharma’s recent plan to move from mass-market molecules into more lucrative vaccines and biologics did not see the anti-vaxer movement coming: millions of Americans saying You Want to Vaccinate Me—and My Child—with WHAT?? and condemning vials of H1N1, rotavirus and MMR vaccines to sit, well, way past their expiration dates. Nor were fears of an international vaccine conspiracy helped by former CDC Director Julie Gerberding resurfacing as President of Merck Vaccines in December. (Nice revolving door if you can catch it.)

Now Pharma is back to creating new diseases, patients, risks and “awareness campaigns” faster than you can say thimerosal (the vaccine preservative that started the backlash).

1. SERM deficiency

A pill to prevent postmenopausal osteoporosis [EJ: See?] packs the “magic three” of drug sales—fear, forever and faith—since you never know if it’s working or you need it but fear stopping. But 15 years after women began swallowing bisphosphonates like Boniva and Fosamax because Pharma-planted bone density machines in medical offices revealed they had “osteopenia”;* bisphosphonates are linked to jaw bone death, esophageal cancer and causing the fractures they were supposed to prevent. Sorry about that. Now Pharma is hawking Selective Estrogen Receptor Modulators (SERMs) like Evista and Tamoxifen to prevent osteoporosis and even some cancers. Unfortunately they can cause others...

2. Statin Deficiency

If it seems like the whole world is on statins, it’s not your imagination. Last year the FDA approved AstraZeneca’s Crestor for children as young as 10 and in March it approved Crestor for 6.5 million people who have no cholesterol or heart problems at all! (See: fear, forever and

faith.) Many say, since lead investigator of the Justification for the Use of Statins in Primary Prevention study Paul Ridker of Brigham and Women’s Hospital in Boston is co-patent holder/inventor of the C-reactive protein (CRP) test which “proves” Crestor’s effectiveness, there’s a conflict of interest. Others say, since CRP isn’t necessarily even a marker for heart disease and statins can cause Type 2 diabetes, it’s bad science along with a conflict of interest.

3. Circadian Dysrhythmia—[Circadian seems related to crickets?]

Insomnia is a gold mine for Pharma because everyone sleeps—or watches TV when they can’t. But Ambien, Lunesta, Sonata and Rozerem have reached market saturation, so Pharma is rolling out subcategories like nocturnal, middle-of-the-night (MOTN) and terminal insomnia and sleep eating, sleep walking and sleep sweating (yes sweating) to boost the franchise. Meanwhile another demo is swelling Circadian Dysrhythmia numbers: Thanks to restless legs syndrome, sleep apnea, shift work sleep disorder, people who skimp on sleep and of course insomnia meds themselves, there’s an epidemic of excessive sleepiness! Enter Provigil—“a mood-brightening and memory-enhancing psychostimulant which enhances wakefulness and vigilance,”—Adderall and Vyvanse, known in the days of Lenny Bruce—also an “excessive sleepiness” sufferer—as speed. [EJ: Yeah, Elvis loved Speed.]

4. Adult Autism, ADHD and Refusal to Play Nicey

Having marketed adult diseases like depression, bipolar disorder and schizophrenia in 4-year-olds to death, Pharma is now finding childhood diseases in adults. Adults with ADHD have hyperactivity, impulsivity, “executive function deficits” and “difficulty with organization and time management,” says Harvard Medical School’s Joseph Biederman, in a 2004 JAMA. The disease, found in most people’s brother-in-laws, requires “lifelong” medication says Biederman, who was accused of pushing Risperdal and hiding Pharma income by Congress in 2008. Adults may suffer from autism too says a 2008 article in *Psychiatric News*, if they’re “unsociable, extremely rigid, given to angry outbursts” and “acutely sensitive to light, heat, and pain.” Luckily, in two studies “SSRI antidepressants led to a decrease in repetitive behaviors and to somewhat more socializing,” in adults with autism says *Psychiatric News*.

5. Asthma That Requires “Two Drugs”

Leave it to Pharma to develop an asthma drug—the long-acting beta2-agonists (LABAs)—that triples the rate of asthma deaths, especially in African-Americans. And leave it to the FDA to approve LABA’s on the basis of a trial, the 2003 SMART trial (Salmeterol Multicenter Asthma Research Trial) that was stopped early because of so many deaths. In March, after more deaths, especially in children, a sheepish FDA recast LABAs as a last resort medication with or without use of a concomitant inhaled steroid. But AstraZeneca doesn’t want to stop selling its LABA with

a steroid, Symbicort—and GSK its LABA with a steroid, Advair—just because they're correlated with death. So the LABA drugs are being billed as safe and able to treat “both” causes of asthma (see: Vytarin) and projected to earn billions this year.

6. “Treatment Resistant” Conditions

If an engine additive or laundry product didn't work, who would chase it with another product—or two—because the manufacturer told them to? Who would pay \$300 to \$900 a month out of their pocket for antidepressants, antipsychotics, mood stabilizers and mood brighteners some of which don't work? (see: fear, forever, faith.) Increasingly, Pharma is approving drugs as add on or “adjunctive therapy” like AstraZeneca's antipsychotic Seroquel, approved last year “for patients who had failed to respond adequately to an antidepressant alone.” Also last year, the FDA approved Eli Lilly's Symbyax, a combination of the SSRI antidepressant Prozac and controversial antipsychotic Zyprexa—do patients gain 100 pounds but feel great—for “treatment resistant depression”. Why are diseases “treatment resistant” instead of the drugs “ineffective” or diagnoses “wrong”? [EJ: Priceless!]

7. Low T

Men are you feeling run down and over the hill? Is your hair falling out, skin wrinkling and abdomen developing its own zip code? Have you lost interest in sex or worse, has your partner? (With you?) Do you need reading glasses, dental implants and heel splints? You're not getting old; you just have Low T and are ready for the “aging-is-really-just-low-hormones” con that women have lived with for 60 years: hormone replacement therapy. Like 50 million women before you, you can be Forever Masculine even though, to (quote hormone giant Wyeth) you have outlived your testes if you start replacing your lost testosterone. You'll get both kinds of zips back in your life, and it won't change your prostate-specific antigens. Pharma promises. [EJ: **Maybe this is the one that really got me. A few years ago there was a beauty contest in a hotel nearby where we had to go for a business meeting. A few days before that I had been reading about testosterone perking up your sex life. Doris said: “Perking up? Maybe resurrecting would be a better word?” Anyway, seeing all that young femininity going to waste nudged me to see if Low T was real so I called Dr. Cantara and he authorized my buying some at the drug store, after admonishing me that it will not do any “good” but I guess it will not do any harm. So I bought and took half a bushel and he was right—it made no impression at all.**]

8. “Spectrum” Disorders

Nothing proves Pharma's “when-the-medication-is-ready” credo better than the legions of people who have fibromyalgia now that Cymbalta, Savella and Lyrica are available to treat it. Still, a “grassroots” Pharma front group is conducting a Fibromyalgia-Is-Real awareness campaign like it did for depression and bipolar disorder, just to make sure. Pharma has also rolled out the term “depression spectrum disorder” for fibromyalgia to make sure patients who have some but not all of the symptoms seek treatment. And speaking of spectrums, “Epilepsy Spectrum Disorder” was rolled out in January's JAMA—a disorder which is not just about seizures anymore but has “shared mechanisms” with “depression, autism..., and other cognitive comorbidities”. Spectrum disorders are Real—which is Pharma for Reimbursable.

* a Pharma contrivance like “Perimenopause” to widen the Patient Pool.
